Fees for immigration procedures will be revised on April 1, 2025.




Fees for immigration procedures, such as change of status of residence and extension of period of stay, will be revised. For applications accepted by March 31, 2025, fees before the revision are applied even if a related permission, certificate, etc. are issued on or after April 1, 2025.

- What procedures do I need to follow to apply for a status of residence online?
- A1

Register user information or file an application for use in advance using the Online Residence Application System.

The foreign national themselves, and their legal representative and relatives (spouse, child, father or mother) can register information of the user with their personal number card.

An attorney and a certified administrative procedures legal specialist are to register information of the user with the certificate of notification. Scan the QR code for more details. ▶



Staff of the organization to which the foreign national belongs, and staff of a public interest corporation or a registered support organization need to file an application for use with the regional immigration services office that has jurisdiction over the location of the organization or corporation and obtain approval.

- What types of applications can I file using the Online Residence Application System?
- A2 The following applications can be filed using the Online Residence Application System.
 - (1) Application for issuance of certificate for eligibility
 - (2) Application for permission to change status of residence
 - (3) Application for permission to extend period of stay
 - (4) Application for permission to acquire status of residence
 - (5) Application for issuance of certificate of authorized employment

- (6) Application for permission to re-entry *Only in cases of filing an application along with an application for any of (2) to (4)
- (7) Application for permission to engage in activity other than that permitted under the status of residence previously granted *Only in cases of filing an application along with an application for any of (2) to (4)

Foreign nationals having any of the statuses of residence, "Diplomat," "Temporary visitor," or some "Designated activities," or foreign nationals who wish to change their status of residence to any of the aforementioned statuses of residence may not use the Online Residence Application System.

- Can I pay fees for permission application using a credit card or other electronic means, instead of paying with a revenue stamp?
- A3 Electronic payments are not allowed.
- Q4 What is a registered user card?
- A4 A registered user card is issued to a person whose registration for using the Trusted Traveler Program (TTP) has been approved.

A person whose registration for using the TTP has been approved can use an e-gate with their registered user card and can finish immigration procedures promptly without receiving a face-to-face immigration check by an immigration inspector at an ordinary immigration booth.

The TTP issues registered user cards to foreign business persons and tourists who intend to stay for a short period for the purpose of business, sightseeing or visiting relatives in Japan, and their families, etc. and who are admitted as a trusted traveler who satisfies certain requirements, and allows them to use an e-gate with their registered user card.

We hope that immigration control policies can be understood even better by the general public and become more familiar to them.
